SPECIAL OFFER WITHIN THE FRAMEWORK OF RESTART REFINANCING LOAN: RESTART PACKAGE

 - ✓ Card credit line option with a limit of up to 5 million AMD, with a 15% annual nominal interest rate (annual effective interest rate: 15.40%-16%), for a period of 12-60 months,

- 2. In case of a loan amount of 150-300 million AMD (including the amount of the additional loan)
